



Dream® Composite Deck

20 YEAR - Limited Warranty

THERMAL INDUSTRIES, INC. (hereinafter "Seller") WARRANTS that its DREAM® COMPOSITE DECK PRODUCTS will not rot, split or suffer structural damage from termites or fungal decay for a period of Twenty (20) Years from the time of shipment to customer.

SELLER'S LIABILITY UNDER THIS WARRANTY IS LIMITED SOLELY TO REPLACEMENT OF DEFECTIVE DREAM® COMPOSITE DECK PRODUCTS OR REFUND AT SELLER'S OPTION. ANY REFUND WITHIN THE FIRST TEN (10) YEARS SHALL BE NON-PRORATED AND THE SECOND TEN (10) YEARS PRORATES ON A STRAIGHT-LINE DEPRECIATING BASIS.

Purchaser's sole and exclusive remedy for any claim whatsoever, whether in contract, warranty, tort or strict liability, arising out of the use, storage or possession of DREAM® COMPOSITE DECK PRODUCTS, including without limitation any claim that DREAM® COMPOSITE DECK PRODUCTS failed to perform as warranted, shall be replaced with substituted DREAM® COMPOSITE DECK PRODUCTS or completely refunded within the first Ten (10) Years with the second Ten (10) Years based on a straight line depreciating basis, at Seller's option.

To obtain replacement or refund, the original owner must submit its claim, together with this warranty certificate, the original purchase invoice indicating the date of purchase, pictures of the defective DREAM® COMPOSITE DECK PRODUCTS, and a detailed written description to the address listed below.

THIS WARRANTY SHALL NOT APPLY TO DREAM® COMPOSITE DECK PRODUCTS THAT HAVE NOT BEEN INSTALLED IN ACCORDANCE WITH SELLER'S AND ICC-ES LEGACY REPORT NO. 21-71 GUIDELINES.

This warranty shall not cover defects due to; 1) natural disasters, including fire, smoke, water, earthquakes, lightning or static electricity; 2) causes external to the DREAM® COMPOSITE DECK PRODUCTS such as, but not limited to, weather; 3) the neglect, abuse, misuse (including faulty installation, repair or maintenance by other than Seller), improper storage of DREAM® COMPOSITE DECK PRODUCTS or other failure to comply with the instructions set forth in the documentation, installation instructions and/or manual accompanying the DREAM® COMPOSITE DECK PRODUCTS; 4) a modification of the DREAM® COMPOSITE DECK PRODUCTS not provided by Seller; 5) a malfunction of any product not provided by Seller with which the DREAM® COMPOSITE DECK PRODUCT is used or combined; 6) use, modification or other treatment of the DREAM® COMPOSITE DECK PRODUCTS in a manner for which it was not designed or intended; 7) defects in articles purchased by Seller and resold by it without alteration and defects in materials purchased by Seller which cannot be discovered by warranty factory inspection; 8) placement under or subjection to abnormal use conditions; or 9) normal wear and tear.

SELLER'S WARRANTY SHALL APPLY ONLY TO DREAM® COMPOSITE DECK PRODUCTS. IN NO EVENT SHALL SELLER BE LIABLE FOR LABOR OR OTHER EXPENSES INCURRED BY THE PURCHASER'S OR SPECIAL, INCIDENTAL, EXEMPLARY OR CONSEQUENTIAL DAMAGES OF ANY KIND WHATSOEVER. SELLER'S LIABILITY ARISING OUT OF THE MANUFACTURE, SALE OR SUPPLY OF THE DREAM® COMPOSITE DECK PRODUCTS OR THEIR USE, WHETHER BASED UPON WARRANTY, CONTRACT, TORT OR OTHERWISE, SHALL NOT EXCEED THE ACTUAL PURCHASE PRICE PAID BY PURCHASER FOR THE DREAM® COMPOSITE DECK PRODUCTS.

Purchaser acknowledges that the DREAM® COMPOSITE DECK PRODUCTS are not structural lumber and therefore may not be used as such. PURCHASER IS SOLELY RESPONSIBLE FOR DETERMINING THE SUITABILITY FOR USE OR APPLICATION OF ANY DREAM® COMPOSITE DECK PRODUCT, OR WHETHER DREAM® COMPOSITE DECK PRODUCTS MEET REQUIREMENTS OF APPLICABLE BUILDING CODES OR SAFETY CODES FOR SPECIFIC APPLICATIONS. No person or entity is authorized by Seller to make and, Seller shall not be bound by any statement or representation as to the performance of DREAM® COMPOSITE DECK PRODUCTS other than what is contained in this warranty.

This warranty shall not be amended or altered except in written instrument signed by Seller and Purchaser. THE FOREGOING WARRANTY IS EXCLUSIVE AND IN LIEU OF ANY OTHER WARRANTIES WITH RESPECT TO DREAM® COMPOSITE DECK PRODUCTS, EXPRESSED OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY IMPLIED WARRANTY OR MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT.

Laws from time to time in force in certain jurisdictions may imply warranties that cannot be excluded or can only be excluded to limited extent. This warranty shall be read and construed subject to any such statutory provisions. This warranty gives you specific legal rights. You may have other rights which vary from state to state.
